#### INTRODUCTION

Church Protocol and Policy have to do with the rules that guide our operation as a church to maintain order and unity.



#### **PROTOCOL:**

"a system of rules that explain the correct conduct and procedures to be followed in formal situations" (Britannica)



#### **POLICY:**

"an officially accepted set of rules or ideas about what should be done"



## USE OF POLICY IS FOUND IN SCRIPTURE

- The Bible is a policy book when you think about it.
- The Law of Moses (5 books of Moses)
- In the New Testament Acts 15 is an example of the need for policy.



## DEVELOPMENT OF POLICY IN ADVENTIST CHURCH

- Adventist pioneers were anti-organization.
- They attempted to avoid anything that sounded like establishing a church organization at the time.
- They had recently announced the "fall of Babylon", which included not only the Roman Catholic church, but the organized Protestant churches.
- They noticed a pattern, that once the church gets organized, she began to stagnate.



#### THE NEED FOR ORGANIZATION

- The need to conduct legal operations.
- The need to implement church discipline.
- The need to establish a paid ministry.
- The need to support missionary activities.


- As church communicator, you are to know your organization.


 We consider them to be inspired writings that is consulted for various areas of Christian living.

#### MINISTERS HANDBOOK


A guide for the pastor on his personal and professional practices.





#### **ELDERS HANDBOOK**


 A guide for church elders on their personal and professional practices within the church.

An official exposition on the doctrines of the church. They are not official policies, but they express how the church interprets the doctrine, they are a source of guidelines.








#### WORKING POLICY

- Policies are dead documents if they are no implemented and applied.
- It is important to understand who is responsible for the implementation of policies within the church.
- This is done by various officers and committees within the church.



#### MANAGEMENT LEVELS WITHIN THE SEVEN-DAY ADVENTIST CHURCH:

- Local church
- Conference
- Union
- General Conference



#### MANAGEMENT LEVELS WITHIN THE SEVEN-DAY ADVENTIST CHURCH:

- Each level is managed by a committee that is led by a chairperson of that committee.
- Each level has rights and limitations on the various policies that they implement and create.
